## **GUESS THE SCORE COMPETITION TERMS AND CONDITIONS**

The Guess the Score competition (the "**Competition**") is a promotion run by Manchester City Football Club Limited (the "**Club**"). By entering, you fully agree and accept these Competition Terms and Conditions ("**Competition T&Cs**") together with any specific instructions and terms for such competition which may be mentioned on the relevant section of the Club's website. For the purposes of these Competition T&Cs:

"Competition Entry"	means a prediction of the final full-time score of the relevant Home Match;
"Ground"	means the Etihad Stadium, Etihad Campus, Manchester M11 3FF, United Kingdom;
	and
"Home Match"	means any Premier League and/or Cup football match played by the Club's first IX
	men's team at the Ground during the Competition Period.

## 1. Who Can Enter

The Competition is open to UK residents aged 13 and over only at the time of entry. Proof of identity and age may be required. Employees of the Club or their families as well as anyone professionally connected with the Competition are not eligible to enter.

To enter the Competition, entrants must have a mobile phone with access to the internet.

All entries must be made directly by the person entering the Competition.

If you are under 18 years of age you must have parental or legal guardian before participating in the Competition. The Club reserves the right to request that you provide contact details of a parent / legal guardian as part of the submission process and may contact your parent or legal guardian to verify such prior permission. Where a prize involves travel of any description, any winner under the age of 18 must be accompanied by an adult.

By entering the Competition you warrant that all information submitted by you is true, current, and complete.

#### 2. How to Enter

The Competition will run in respect of all Home Matches between 18<sup>th</sup> September 2021 and 22<sup>nd</sup> May 2022 (inclusive) (the "**Competition Period**"). The Club will carry out a number of prize draws (each a "**Prize Draw**") during the Competition Period which you can enter for a chance to win the Prizes. A Prize Draw will occur in relation to every Home Match during the Competition Period.

Entry to the Competition is free.

To enter the Prize Draw for any Home Match, you must submit your Competition Entry no earlier than 2 hours before kick-off and no later than 5 minutes before kick-off (the "**Submission Period**"). By way of example, if the relevant Home Match starts at 3pm BST on 18<sup>th</sup> September 2021, you must submit your Competition Entry between 1pm BST and 2.55pm BST on 18<sup>th</sup> September 2021.

Any Competition Entries received outside of the Submission Period will not be considered for the Prize Draw, even if they appear to be registered.

To enter you need to scan the dedicated Competition URL (QR code) and complete the online entry form. You will be asked to enter your details including your name, age, email address, phone number and address. You'll also need to provide details of your Competition Entry.

#### 3. Other Conditions for Entry

Only one Competition Entry permitted per person per Home Match.

One winner will be selected per Home Match.

All winners will be chosen at random by a computerised random generator from all valid Competition Entries received within the Competition Period and the Submission Period and verified by the Club and or its agents.

If you are a winner, you will be notified by email or phone by no later than 14 days after expiry of the Competition Period. Reasonable efforts will be made to contact the winners. If the winners cannot be contacted within 14 days of notification, or are unable to comply with these Competition T&Cs, the Club reserves the right to offer the prize to the next eligible entrant drawn at random.

In the event that no one submits a valid and correct Competition Entry for any Home Match, then the winner for that Home Match will be chosen at random by a computerised random generator from all valid Competition Entries which predicted the correct outcome (but not the correct score). By way of example, if the final score of

the Home Match is 5-1, but no one predicted a final score of 5-1, then a winner will be chosen from all Competition Entries that predicted a win for the Club.

Prizes may, at the Club's sole discretion, be delivered to addresses in the UK or made available for collection at the Ground.

The Club is not liable for delayed or non-delivery of Prizes for any reason beyond its control, including but not limited to loss or theft in transit or any failure by you to accept delivery of a Prize for any reason.
